

# INTRODUCING THE SPEAKERS



Patty Fleischmann is an active community leader and has co-chaired a number of fundraisers and events for important causes, often alongside her husband. Her private practice is busy and fulfilling but she has always been eager to do more, to leave a lasting legacy of giving back. Four years ago, she was asked to be a part of "SOLD," a film about the international issue of child trafficking, scheduled for wide release in 2015. Deeply saddened by the plight of trafficked children and inspired to do more, Patty decided to look at what was being done to combat the issue within her own community, Seattle. After learning that there are an average of over 500 sexually exploited youth in King County alone, she brought together a group of passionate and committed women and founded the non-profit StolenYouth. StolenYouth supports the rescue and recovery of trafficked children through advocacy and fundraising. Patty has served as the

President of the Board for the last three years and is proud of the tremendous work that StolenYouth has done in such a short time. She is beyond grateful to the community that continues to stand up against youth trafficking in Seattle. She is currently a licensed marriage and family therapist in Washington State and has been practicing for 23 years. She is married with two teenage kids and a puppy.



Jane Charles, with 20+ years in the film industry, has recently produced the films: Switchmas, Fat Kid Rules the World, Grassroots, and SOLD, with Oscar-winning director Jeffrey Brown and executive producer Emma Thompson, which was filmed in India & Nepal and won "Best Narrative Feature" at AFME and the audience award at LIFF in London. Jane's first feature films as producer, Cyberteens In Love and Once In a Blue Moon, were distributed internationally, and premiered at the Montreal and Toronto International Film Festivals. She has also produced countless television commercials, television shows and music videos for Sting, Harry Connick Jr and Our Lady Peace. Beginning in 1996, as Executive Producer, Jane successfully ran Apple Box Productions (1996 – 2002) and Run Spot Run Films (2002 – 2007) before relocating to Seattle, WA where she is an impact producer, making cause-based films that entertain and enlighten and is co-founder of the non-profit Stolen Youth.



Sen. Jeanne Kohl-Welles, D-Seattle, has represented the 36th Legislative District in the Senate since 1994 after serving for three years in the state House of Representatives where she was Majority Whip. In addition to her position as ranking member of the Senate Higher Education Committee, Jeanne sits on the Senate Ways & Means, Rules, and Commerce and Labor committees. She represents Washington on the Western Interstate Commission for Higher Education, on the Education Committee of the National Conference of State Legislatures, and on the Committee on Advanced Tuition Payment. Jeanne is also a member of the UW Women's Center Anti-Trafficking Task Force and, most recently, was named to the Statewide Coordinating Committee on Sex Trafficking and the Commercially Sexually Exploited Children Statewide Coordinating Committee. Her legislation regulating international matchmaking organizations (mail-order bride protections) was the first enacted in the United States and served as a model for the

International Marriage Broker Regulation Act, enacted in 2005 and sponsored by U.S. Senator Maria Cantwell, D-WA, and U.S. Rep. Rick Larsen, D-WA. Thirteen of her anti-trafficking bills have been enacted into law since 2002.



**Dr. Dana Raigrodski** is a Lecturer and Director of the General LL.M. track at the University of Washington School of Law. She is also the Executive Director of Global Affairs at the Law School. She is a member of the University of Washington Women's Center Anti-Trafficking Task Force and chairs the task force committee on continuing legal education. She assembled the program "Human Trafficking: Forced Labor and Corporate Responsibility" and took part in the planning of an international conference on "Human Trafficking in the Era of Globalization." Dr. Raigrodski holds an LL.B magna cum laude, Tel Aviv University and an LL.M with distinction and SJD from Tulane University. She is a member of the New York and the Israel Bar. She previously practiced law as a military prosecutor for the Israeli Defense Forces Military Advocate General Staff Command in Tel Aviv. Professor Raigrodski teaches legal research and writing and comparative legal studies; her scholarship and research interests examine human trafficking and globalization, criminal procedure and jurisprudence, and law and development.

### WHAT IS HUMAN TRAFFICKING?

The Trafficking Victims Protection Act defines "severe forms of trafficking in persons" as:

- Sex trafficking in which a commercial sex act is induced by force, fraud, or coercion, or in which the person induced to perform such an act has not attained 18 years of age; or
- transportation, provision, or obtaining of a person for labor or services through the use of force, fraud, or coercion for the purpose of subjection to involuntary servitude, peonage, debt bondage, or slavery.

A victim need not be physically transported from one location to another in order for the crime to fall within these definitions.

## **QUICK FACTS**

- Almost 21 million people are victims of forced labor – 11.4 million women and girls and 9.5 million men and boys.
- Almost 19 million victims are exploited by private individuals or enterprises and over 2 million by the state or rebel groups.
- Of those exploited by individuals or enterprises,
   4.5 million are victims of forced sexual exploitation.
- Forced labor in the private economy generates US\$150 billion in illegal profits per year.
- Domestic work, agriculture, construction, manufacturing, and entertainment are among the sectors most concerned.
- Migrant workers and indigenous people are particularly vulnerable to forced labor.
- About 293,000 U.S. children mostly girls aged 12 to 14 — are at risk of being exploited and trafficked for sex, according to a March 2011 FBI report.
- Minors recruited or abducted into prostitution often are runaways or come from abusive homes or foster homes.
- The minors are advertised on websites and taken to streets, hotels, brothels, strip clubs, and truck stops.
- An estimated 70 percent to 90 percent of youth victims of sex trafficking have histories of sexual abuse.

A \$32 billion annual industry, modern day trafficking is a type of slavery that involves the transport or trade of people for the purpose of work. According to the U.N., about 2.5 million people around the world are ensnared in the web of human trafficking at any given time.

## How to Identify a Human **Trafficking Victim**

- Seems anxious, fearful or paranoid. Avoids eye contact.
- Unexplained bruises or cuts or other signs of physical abuse.
- Appears to be in a relationship with someone who is dominating.
- Never is alone and/or always has someone translating or answering questions on their be-
- Not in control of their own finances.
- Presents with secrecy or unable to answer questions about where they live.
- Inconsistent details when telling their story.
- Has no identification such as a license, passport or other ID documents.
- Inability to leave their job or residence. Says they cannot schedule appointments.
- Is under 18 and providing commercial sex acts. Or at any age unwillingly providing commercial sex acts.
- Is afraid of law enforcement or receiving help from an outside entity.





## What is Modern Day Slavery? Investigating Human Trafficking (03/06/2012)

<u>Overview</u>: In this lesson, students learn about human trafficking, also known as modern slavery, and how it has become one of the largest industries in the world. Using coverage of human trafficking by Nicholas D. Kristof, a New York Times columnist, they explore the causes of and consequences for victims and traffickers, the role of globalization and ways to respond effectively.

Before students arrive, put the term "human trafficking" on the board and invite students to define the term. Write definitions or create a word web on the board with the words and phrases students contribute. Then clarify any misunderstandings and provide them with the definition.

Warm up: Ask students to complete a True or False quiz with the following five statements:

Human Trafficking only affects underdeveloped countries where poverty is an extreme problem.

Human trafficking is the fifth largest criminal industry worldwide.

The estimated global annual profits made from the exploitation of all trafficked forced labor are \$31.6 million.

The majority of trafficking victims are 18 to 24.

Numerous Internet sites are used to facilitate sex trafficking.

<u>Activity One:</u> Students will now read a piece about human trafficking by Nicholas D. Kristof, a New York Times columnist who has made human trafficking one of the focal points of his work. Read <u>"Fighting Back, One Brothel Raid at a Time"</u> in which Mr. Kristof puts the story of one human trafficking activist into broader context.

#### Questions for discussion:

Who is Somaly Mam, and what work does she and her foundation do?

How many people, including children, are thought to be engaged in false labor, including sexual servitude?

What kinds of challenges and risks face those in the anti-trafficking movement?

According to Mr. Kristof, what is the way to end human trafficking and sexual slavery?

What signs of progress has Mr. Kristof observed?

<u>Activity Two:</u> Split the class evenly into two groups. Explain that each group will delve deeper into an aspect of human trafficking. Group 1 will look at the overall picture of human trafficking, and Group 2 will explore the contributing factors. Provide each group with the following guiding prompts:

Group 1 Task: To investigate where human trafficking is occurring and in what forms, and how it has played out worldwide.

Group 2 Task: To investigate the roots of human trafficking and the factors that play a large role in the industry.







### **The Tiers**

**Tier 1:** Countries whose governments fully comply with the Trafficking Victims Protection Act's (TVPA) minimum standards

**Tier 2**: Countries whose governments do not fully comply with the TVPA's minimum standards but are making significant efforts to bring themselves into compliance with those standards.

**Tier 2 Watch List**: Countries whose governments do not fully comply with the TVPA's minimum standards, but are making significant efforts to bring themselves into compliance with those standards AND:

- a. The absolute number of victims of severe forms of trafficking is very significant or is significantly increasing
- There is failure to provide evidence of increasing efforts to combat severe forms of trafficking in persons from the previous year; or
- c. the determination that a country is making significant efforts to bring themselves into compliance

**Tier 3:** Countries whose governments do not fully comply with the minimum standards and are not making significant efforts to do so

The date is actually a tribute to the four officials of the Ministry of Labor killed in 2004 during an investigative operation in the rural zone of Unaí, state of Minas Gerais. Ten years have passed and still slave labor remains in Brazil.
